# **Executive Director's Report:**

- Lauterbach & Amen, L.L.P. have officially begun work as our new accountants. Positive changes have been noticed.
- Interviewing 2 applicants today. Both underwent the psyche evaluation done by Dr. Selvig and it has proved to be very insightful.
- Union talks are going well & we are hopeful in getting a deal signed before the Executive Director's departure.

# **CAD Update**

- We went live with CAD September 22<sup>nd</sup> and have a punch list of about 20 (down from 40) items. We will continue to work with Sungard to fix them.
- Sungard is owed \$114,000. Although, the agreement is to issue payment 30 days after the go live date, the payment will be withheld until bugs are worked out.
- Ted & Chris are working on the connectivity issue that Elmwood Park is experiencing.
- Chief Fagiano expressed his concerns and inquired about someone from Sungard coming out to assist with RMS.
- The cost and options for citation software were discussed.
- The CAD status call included 20 users that dialed in last week and 3 this week.
- The survey monkey done at the beginning of the CAD project was not accurate as is concerns the number of licenses needed. More Visio licenses are needed. The cost is \$230 per license.
- The state of Illinois is requiring 20 examples of accident reports before they will allow transmittals.

# WSCDC FY 2016 Budget
